## Ontario SPCA and Humane Society Events Terms and Conditions

The Ontario SPCA's terms and conditions for events are set out in full below. All attendees agree to comply with the Ontario SPCA and Humane Society Events Code of Conduct Policy and regulations found within.

These Terms and Conditions ("Terms"), along with the Events Code of Conduct for the Ontario Society for the Prevention of Cruelty to Animals ("Ontario SPCA and Humane Society") apply to any person, guest, registrant, student, speaker, vendor, or exhibitor ("Attendee") who is present at any meeting, conference, or event ("Event") of the Ontario SPCA and Humane Society, including post-event access to resources. By attending the Event, the Attendee will be deemed to have accepted these Terms and the Events Code of Conduct for the Ontario SPCA and Humane Society.

### **PROGRAM CHANGES**

It may be necessary for reasons beyond our control to change the content and timing of the program, the speakers, and/or the date at any time prior to and at the time of the event. Every effort will be made to keep presentations and speakers as represented. However, unforeseen circumstances may result in the substitution of one or more presentation topic(s) and/or speaker(s).

### **RECORDING**

Audio and video recording may take place during in-person and virtual events. Attendees hereby grant the Ontario SPCA and Humane Society and its licensees, affiliates, employees, and representatives permission to record them at the Event, and distribute and publish (both now and in the future) the Attendee's name, image or voice in photographs, video and/or audio recordings, electronic reproductions. I consent to and authorize, in advance, such use and waive any rights of privacy and/or publicity I may have in connection therewith. The Ontario SPCA and Humane Society appreciates all coverage of Event. Audio and video recordings are permitted for personal, non-commercial use. Attendees are prohibited from recording sessions for their own personal use and/or distribution. Prior written consent of the Ontario SPCA and Humane Society is required for all other uses.
